MEMORANDUM FOR DISTRIBUTION A & I

SUBJECT: Traditional Position Announcement with **CO E 1ST BN 135TH AVN RGMT CLINTON, MO (SWVA #17-0542)**

1. **CO E 1ST BN 135TH AVN RGMT CLINTON, MO** has a vacant **92F40, EFFECTS NCO** position (Para/Line **503/02**). The current EPS list has been exhausted and the position is now open statewide.
2. A **92F40, Petroleum Supply Specialist** receives and stores bulk and package POL products. Issues and dispenses bulk fuels and water from storage and distribution facilities to using units. Selects and submits samples of POL to laboratory for testing. Performs petroleum and water accounting duties. Operates equipment associated with petroleum and water distribution system and multi-product pipeline system. Fuels and defuels vehicles, aircraft and stationary equipment. Takes emergency precautions to prevent harm to self and facilities in event of petroleum spillage or fire. Supervises and monitors quality assurance programs and activities. Ensure compliance with fire and safety regulations.
3. **MOS requirements:** Applicant must possess the 92F MOS as a primary, secondary or alternate MOS.
4. **Select Reserve Bonus Consideration:** Any change in a Soldier's MOS, except as provided by normal rank progression as outlined in DA PAM 611-21, is not allowed and will terminate that Soldier's Select Reserve Incentive Program bonus, with recoupment. Accepting a SWVA slot is voluntary change of MOS and falls outside of normal rank progression. Please consult your bonus contract and the Education & Incentives office at State if you have any questions.
5. **Who May Apply:** Current MOARNG Soldiers in grades E5 to E7 who hold the MOS as a primary, secondary or alternate MOS or those who can be awarded the MOS without attending reclassification training, and E7 Active Army and USAR Soldiers who are 92F MOS qualified. Any Soldier who is not on the current EPS list. Transfer into the para/line is authorized. Upon completion of the requirements for promotion (MOSQ, NCOES, TIG, TIS), all pertinent information will be sent to NGMO-PER-E for the next scheduled EPS Board or STAB. Once the Soldier appears on the EPS list, a request for promotion can be submitted. See the MOARNG 2017 EPS MOI, dated 29 September 2016.
