MEMORANDUM FOR DISTRIBUTION A & I

SUBJECT: Traditional Position Announcement with HHD 1107TH AVN GRP (TASMG), Springfield, MO (SWVA #17-0550)

1. HHD 1107TH AVN GRP (TASMG), Springfield, MO has a vacant 56M30, CHAPLAIN ASSISTANT NCO position (Para/Line 110/02). The current EPS list has been exhausted and the position is now open statewide.
2. A 56M30, Chaplain Assistant is primarily assigned to a brigade level headquarters. Leads subordinates in execution of religious support operations. Manage *battle focused training* for the UMT. Supervise communications and Operations Security (OPSEC) for religious support operations. Manage tasking in support of religious support operations. Develop the religious support plan and synchronizes religious support operations in JIIM formations across the full spectrum of operations. Supervise subordinate UMT indigenous religions analysis process. Conduct Traumatic Event Management (TEM). Trains subordinates in counseling skills. Supervise establishment of multi-purpose religious support facilities. Determine assignment strategies and force structure requirements.
3. **MOS requirements:** Applicant must possess the 56M MOS as a primary, secondary or alternate MOS.
4. **Select Reserve Bonus Consideration:** Any change in a Soldier's MOS, except as provided by normal rank progression as outlined in DA PAM 611-21, is not allowed and will terminate that Soldier's Select Reserve Incentive Program bonus, with recoupment. Accepting an SWVA slot is a voluntary change of MOS and falls outside of normal rank progression. Please consult your bonus contract and the Education & Incentives office at State if you have any questions.
5. **Who May Apply:** Current MOARNG Soldiers in grades E4 to E6 who holds the MOS as a primary, secondary or alternate MOS or those who can be awarded the MOS without attending reclassification training, and E6 Active Army and USAR Soldiers who are 56M MOS qualified. Any Soldier who is not on the current EPS list, transfer into the para/line is authorized. Upon completion of the requirements for promotion (MOSQ, NCOES, TIG, TIS), all pertinent information will be sent to NGMO-PER-AB for the next scheduled EPS Board or STAB. Once the Soldier appears on the EPS list, a request for promotion can be submitted. See the MOARNG 2017 EPS MOI, dated 29 September 2016.
