MEMORANDUM FOR DISTRIBUTION A & I

SUBJECT: Traditional Position Announcement with **CO D 1ST BN 135TH AVN RGMT
WHITEMAN AFB, MO (SWVA #17-0596)**

1. **CO D 1ST BN 135TH AVN RGMT WHITEMAN AFB, MO** has a vacant **15G20, ACFT STRUCT REP** position (Para/Line **409/02**). The current EPS list has been exhausted and the position is now open statewide.
2. A **15G20, Aircraft Structural Repairer** repairs and replaces aircraft structural components to include stingers, longerons, bulkheads, beams and aircraft skin according to drawings, blueprints, directives, technical manuals and safety procedures. Fabricate structural parts, forming blocks, and shapes metal using stretching, shrinking, and other metal forming techniques. Mixes and applies fiberglass materials. Makes emergency and permanent repairs to transparent plastic windows and enclosures. Uses common measuring tools, precision measuring gages, and alignment fixtures to perform structural repairs. Balances fixed-wing aircraft controls such as flags and ailerons. Mixes and applies primers and paints to aircraft surfaces. Apply corrosion control treatment to aircraft metals. Maintains facilities for storage of flammable and hazardous materials. Requisitions and maintains shop and bench stock for repair of aircraft structures. Prepares forms and records related to aircraft maintenance. Provides technical guidance to subordinate personnel. Diagnoses airframe structural integrity IAW drawings, blueprints, directives, technical manuals and manufacturing engineers. Monitors hazardous material control and storage.
3. **MOS requirements:** Applicant must possess the 15G MOS as a primary, secondary or alternate MOS.
4. **Select Reserve Bonus Consideration:** Any change in a Soldier's MOS, except as provided by normal rank progression as outlined in DA PAM 611-21, is not allowed and will terminate that Soldier's Select Reserve Incentive Program bonus, with recoupment. Accepting a SWVA slot is voluntary change of MOS and falls outside of normal rank progression. Please consult your bonus contract and the Education & Incentives office at State if you have any questions.
5. **Who May Apply:** Current MOARNG Soldiers in grades E3 to E5 who hold the MOS as a primary, secondary or alternate MOS or those who can be awarded the MOS without attending reclassification training, and E5 Active Army and USAR Soldiers who are 15G MOS qualified. Any Soldier who is not on the current EPS list. Transfer into

the para/line is authorized. Upon completion of the requirements for promotion (MOSQ, NCOES, TIG, TIS), all pertinent information will be sent to NGMO-PER-E for the next scheduled EPS Board or STAB. Once the Soldier appears on the EPS list, a request for promotion can be submitted. See the MOARNG 2017 EPS MOI, dated 29 September 2016.
