MEMORANDUM FOR DISTRIBUTION A & I

SUBJECT: Traditional Position Announcement with CO A(ASC) 1107TH AVN GRP TSMG, Springfield, MO (SWVA #17-0651)

1. **CO A(ASC) 1107TH AVN GRP TSMG, Springfield, MO** has a vacant **15B30, ACFT POWER PLANT REP** position (Para/Line **211/03**). The current EPS list has been exhausted and the position is now open statewide.
2. A **15B30, Aircraft Powerplant Repairer** removes, replaces, services, prepares, preserves, cleans and stores engine assemblies or components. Disassembles, repairs, reassembles, adjusts, diagnostically test turbine engine systems, subsystems and components according to drawings, blueprints, directives, technical manuals. Assists in troubleshooting engines and rigging engine controls. Performs limited maintenance operational checks. Uses and performs operator maintenance on ground support equipment common and special tools. Maintains facilities for storage of flammable and hazardous materials. Requisitions and maintains shop and bench stock for repair of aircraft engines. Prepares requests for turn-ins and repair parts and engine components and provides technical guidance to subordinate personnel. Diagnoses and troubleshoots malfunctions in aircraft engines and their components. Participates in maintenance test flights as required. Monitors hazardous material control and storage. Prepares forms and records related to MOS.
3. **MOS requirements:** Applicant must possess the 15B MOS as a primary, secondary or alternate MOS.
4. **Select Reserve Bonus Consideration:** Any change in a Soldier's MOS, except as provided by normal rank progression as outlined in DA PAM 611-21, is not allowed and will terminate that Soldier's Select Reserve Incentive Program bonus, with recoupment. Accepting an SWVA slot is a voluntary change of MOS and falls outside of normal rank progression. Please consult your bonus contract and the Education & Incentives office at State if you have any questions.
5. **Who May Apply:** Current MOARNG Soldiers in grades E4 to E6 who holds the MOS as a primary, secondary or alternate MOS or those who can be awarded the MOS without attending reclassification training, and E6 Active Army and USAR Soldiers who are 15B MOS qualified. Any Soldier who is not on the current EPS list, transfer into the para/line is authorized. Upon completion of the requirements for promotion (MOSQ,
