5. Purpose: To increase gender diversity in the MOARNG. Council members will provide advice and assistance on matters including, but not limited to, issues affecting policy, plans, programs, resources, training, readiness, retention and professional development of MOARNG female Soldiers. This Council will review and discuss open agenda items and introduce emerging initiatives for possible elevation to the Executive and Joint Women's Mentorship Councils. The monthly meetings are intended to present, review, discuss statistical data; identify inhibitors; solidify results; identify professional development/mentorship opportunities; receive briefings; and afford the opportunity to all members to discuss a variety of issues in an open forum. Each member will participate in the development and promotion of the mentoring process throughout their particular command or area of influence.

6. Period: Minimum Two Year Term.

7. Special Instructions: A recorder (without vote) will be appointed by the President. The recorder will keep full and detailed records of all meetings.
